### **Steps to follow:**

Remember, everything in red is something that is likely to need to be changed. You need to read each and every word on these documents, match the formatting and alter them accordingly. In the instance that any of the documents have the Certificate of Live birth/Information Registration Statement/application for citizenship certificate then you have to put in the title of your document as it changes across different States; you do not leave both in there or need the / symbol, so delete the irrelevant parts.

Get certificate of live birth/Information Registration Statement and Birth Certificate OR your Application for Citizenship and Citizenship Certificate.

Authenticate the certificate of live birth/Information Registration Statement OR your Application for Citizenship.

the reality is that it is not strictly necessary to authenticate any documents, but it does add enormous weight to the process that we are doing, and it is by far the more ideal circumstance that we do have these documents authenticated, for the reasons outlined in the more generic document discusing why we are even doing this process.

While you are waiting for them to arrive/get returned:

- buy an a4 registered mail envelope from the post office for the main mailing to the governorgeneral, because you need that registered mailing number to use on the footer of your documents and also as the trust indenture identification for claiming and assignment on the UCC.
- buy a red ink pad from the post office/newsagent to use for your thumbprint when signing off on your documents .
- fill out and execute the Generic Reversion documents, including the document relating to your children if you have any. Do not complete the document titled "6. Certificate of Registration of Reversion single biblical" as yet. DOUBLE CHECK THE ADDRESSES and OFFICE HOLDERS
- fill out and execute the power of attorney document and scan it to get a digital copy.

- do the UCC1 filing bailor-bailee including uploading as an attachment the executed scanned power of attorney document. Download a copy of that executed UCC1 and copy the URL/web address of the filing. Print out a copy of the UCC1.
- do the UCC1 filing claim of trust Download a copy of that executed UCC1 and copy the URL/web address of the filing. Print out a copy of the UCC1.
- do the UCC3 filing of the assignment of trust. Download a copy of that executed UCC3 and copy the URL/web address of the filing. Print out a copy of the UCC3 filing.

- do the PPSR filing, pasting both the URL/web address of the filing of the two UCC1 filings and the UCC3 filing into the verbiage into that filing. Download a copy of that executed PPSR and copy the URL/web address of the filing. Print out a copy of the PPSR filing.
- Insert both of the the UCC URL/web addresses and filing numbers into the the document "6. Certificate of Registration of Reversion single biblical" at point 4.
- Insert both of the the PPSR URL/web addresses and filing numbers into the the document "6. Certificate of Registration of Reversion single biblical" at point 5.
- insert that registered mailing number of the mailing sent to the governor general into the document "6. Certificate of Registration of Reversion single biblical" at point 8. "Registration Number".
- follow the instruction in the "Send something in Handwriting" by handwriting the verbiage and inserting the registered mail number.
- you will need to affirm and then attach the "Affidavit merger" to the Birth Certificate with a



paperclip or bulldog clip

- On every printed document, please ensure to place a 5 cent stamp on the back of the page, in the bottom right hand corner, and date through and sign through that stamp then scan those for sending to the governor general and print/photcopy them for the rest of the mailings; the parasites reputedely have a tendency to turn the document over and pretend that the page is blank and so they do nto have to action it. But they resile at seeing that stamp cancelled out and realising that you have accepted the offer of probity provided by the post master general. Will it stop them from being openly corrupt? Also, use the A4 variety, folding the documents to fit in the smaller envelopes will likely cause them to be too thick to be accepted for mailing by Australia Post.
- Also include two fifty (50) cent international stamps that is not stuck to anything to act as substance consideration for the efforts of the Trustee, so that they can be held to more than just a gratuitous level of obligations.

For those who still don't understand, the birth certificate is the equivalent of the citizenship certificate and represents the legal title to the PERSON. ideally in the case of a married woman you would include a photocopy of your marriage certificate paperclipped/bulldog clipped to the birth certificate, and in the case of someone who has migrated you would include a photocopy of your name change certificate paperclipped/bulldog clipped to the birth certificate. If you don't have a name change certificate, then clearly don't worry about attaching what doesn't exist.

### the tail does not wag the dog

In that instance, in the power of attorney in the second paragraph on page 5 of 9, after where the below yellow highlight ends on that page add this following sentence to suit your circumstances:

The executor revokes any and all previous Trustee/s, Power of Attorney or Administrator/s acting under any assumptions, presumptions, whether implied or stated, or given in ignorance or under coercion in any wise, and will no longer accept any person, company or corporation to act in any capacity of Power of Attorney, Administrator, Trustee, and others, without express prior written authorisation from the office of executor of the JOHN ROBERT DOE, Estate, other than where it is repugnant to or in conflict with the currently existing Power of Attorney held in the name of Name of Relative/whoever dated whateverdate in which instance this document yields.

Take a copy with you to give to the other government if you go back there for a holiday. if you go back to live there or move to another country entirely, then just use same process to hand over any potential future reversionary interest to the dejure version of that government (whatever was the constitution was before the introduction of social security in the 1930s) give to the secretary of the treasury if you dont have a governor general.
