Okay, so just a couple of updates since the March 2022 re-release date of the documents:

Boris was kind enough to provide further information, where he emphasised both the necessity to ensure that we make it known in the paperwork with an indisputable clarity that we hold and uphold our allegiance to our God. He also emphasised that it was equally important to make it clear that we have renounced any of our potential "Crown allegiances" (whether real or presumed); they are essential elements to deal with and documents are provided below with highlighted portions to underscore it.

Boris also said that the UCC filing from the Law of Boris videos was the UCC that caused the mortgage to be settled with accord and satisfaction and so it would seem the more practical one to use as a template, as provided below for your consideration.

This update is current at 10th November, 2022.

There are number of common questions and comments which I have hoped to address in this update by adjusting the templates.

One particularly obvious, in hindsight, addition is **that we will need to also send a copy of the entire reversion package to the occupant of the Office of Land Titles wherever bornState** BUT first we need to download the affidavit of majority that has been updated and affirm it again. So if you have already done the process, download the new affidavit of majority and affirm that one to photocopy and send a copy with the rest of the process to the Registrar of Titles in your birth State, ie, Elizabeth Dunn as occupant of the office of Registrar of Titles Queensland.

The Registrar of Titles is **the person responsible for managing land titles in Victoria/where ever**. A land title is an official record of who owns a piece of land, and is now called a 'folio of the register'. It can

also include information about mortgages, covenants, caveats and other encumbrances affecting land.

Affidavit of majority

We use an affidavit of majority to demonstrate that “the age of majority” has been reached and we hold co-ownership of the PERSON, which needs to be attached to the **birth certificate/citizenship certificate** (by a paperclip/bulldog clip NOT stapled as a staple punctures the PERSON vessel causing it to sink under the corporate presumptions. The parasites really are **that** pathetic.) under a construct that is very simliar to “minnesato rule 220” where the affidavit is affirmed in front of a justice of the peace to claim our use of the PERSON created by the use of the fictional birth certificate:

“Rule 220.Birth Certificates

The Registrar of Titles is authorized to receive for registration of memorials upon any outstanding certificate of title an official birth certificate pertaining to a registered owner named in said certificate of title showing the date of birth of said registered owner, providing there is attached to said birth certificate an affidavit of an affiant who states that he/she is familiar with the facts recited, stating that the party named in said birth certificate is the same party as one of the owners named in said certificate of title; and that thereafter the Registrar of Titles shall treat said registered owner as having attained the age of the majority at a date 18 years after the date of birth shown by said certificate."

The occupant of the Office of man/woman trading as the Registrar of Titles is responsible for maintaining registers of titles and all activities relating to real property and is the one who needs to adjust the records for the age of majority. So citizenship certificate as well

The timing in relation to the birth certificate and having reached the age of majority 18 years later is fairly obvious, but in relation to a citizenship certificate the timing would be immediate if when you applied you were over 18 years old. The question remains whether the State holds the records at land titles for immigrants as well as for locals, BUT IF the result is that the immigrants keep getting their package to landtitles returned and the locals do not, we will probably instead start sending the package of the immigrants to DFAT to record 'somewhere'.

Other than that I adjusted and gave ideas on how to refine the power of attorney if you already had one in place with your family that you did not want to void.

Added clarity in the templates as to the direct connection between an australian born birth certificate being the equivalent of a migrants australian citizenship certificate and likewise the certificate of live

birth/birth registration statement/birth information
statement/application for citizenship form.

Added clarity for married women or migrant name changes, in regards, “nee”.

I have added a reminder at the end of steps to follow where to re-read for finer instructions.

Updates for November 2022
